## Committee Update – October 2017

**The Committee met on 6 October 2017.**

### Key points from the meeting are:

- As part of the Settlement Pattern Review, the Committee is holding a series of workshops to give strategic direction on specific aspects of the project. At this meeting the Committee received a presentation on transport. The purpose of the presentation was to highlight strategic transport matters and work currently underway across the Partnership that will be a contribution to the integration of land use and transport matters. The presentation and discussion covered: land use and transport integration, the legislative and policy framework, transport business cases, an update on key current projects/programmes of work, and the issues driving and enabling changes to the future of transport.
- The Committee endorsed the working agreement between the Partnership and One Voice Te Reo Kotahi. This agreement outlines the commitments the Partnership and OVTRK will make to each other to support the implementation of the UDS Vision and OVTRK Kaupapa.

- Following the formal part of the meeting a workshop was held involving Professor Paul Spoonley (Massey University) discussing the anticipated demographic changes and their implications for Greater Christchurch.
